SAFE BOATING THROUGH EDUCATION

From the Commander Cdr David Walsh, AP



s I write this article for the Palmetto Log, I am looking forward to cruising to the USPS An Inual Meeting in Jacksonville, FL. Two boats from the Charleston Squadron are making the trip. Art and Merle Clark are taking their cruiser "Sunday Drive." Wendy and I are going in our boat "Reely Fun." We planned our cruise using MapTech's Chart Navigator program. Those who have recently taken the Squadron's Piloting course will recognize this program. Chart Navigator is available to Squadron members as a free download from MapTech. The program uses NOAA's Electronic Navigation Charts (also free downloads) to plot courses. We plotted our course in three segments. The first segment goes from Charleston, SC to Thunderbolt, GA. Thunderbolt Marina is familiar to some of our members, because The Charleston Power Squadron went there last year for a weekend cruise. Our next segment takes us to Jekyll Island, GA. Jekyll Island was a summer retreat for the rich and famous in the early 1900's. Now it is a state park where the public can stay and tour lavish mansions and restored facilities. Out last leg of our journey takes us to the River City Marina in Jacksonville, FL. According to Chart Navigator our cruise will total of 295 miles. The longest portion of the trip is 119 miles form Charleston to Thunderbolt, GA. We plan to leave Charleston on Tuesday 20 February and arrive in Jacksonville on Thursday the 22nd. During the cruise we will overnight aboard. Once in Jacksonville, we will stay at the conference hotel.

The USPS Annual Meeting has a full agenda including the Governing Board, and sessions on education, membership and a variety of topics. Of particular interest is the new USPS University. This program consists of short seminars that cover specific topics and boater's needs. They are in a two-hour format, and include valuable take-away guides. Each seminar provides credits toward the soon-to-be-re-

leased USPS Boat Operator Certification program, and credit toward elective courses. The first four of these seminars, available now, are:

- 1. Using VHF Radio and VHF with DSC Radio
- 2. Using GPS
- 3. How to Use a Chart
- 4. On Board Weather Forecasting

The Charleston Squadron has not offered USPS University seminars. However, they are of great interest to the boating public and may be a good way of expanding our public educational offerings. See next month's Palmetto Log for a full report on the Annual Meeting and the USPS University.

Safety Officer P/C John Sikes, AP EIGHT TIPS FOR BOATING SAFETY

- 1. Learn to swim. The American Red Cross offers swimming courses for everyone. If you're not comfortable taking a class, arrange for private instruction.
- 2. Take a boating safety course. While our members and their families have probably already done this, we need to encourage friends who go out with us to do so as well. Topics typically include what to do in an emergency, navigation basics, and the effects of wind, water conditions and weather.
- 3. Wear a life jacket. Make sure the boat is stocked with enough Coast Guard-approved life jackets for everyone on board. More than 80 percent of people who drown in boating accidents aren't wearing life jackets.
- 4. Protect your passengers from carbon monoxide. Boat engines emit carbon monoxide, an odorless but deadly gas. To prevent carbon monoxide poisoning, keep passengers away from the engine, both in the boat and in the water. If your boat has a generator to provide electricity while on the water, make sure there's proper ventilation, and install carbon monoxide detectors in sleeping and living quarters.
- 5. Share your plans. Make sure someone on land knows where you plan to go and when you plan to return. A float plan is an important tool in case the Coast Guard needs to be called to locate you.
- 6. Avoid alcohol. Water sports and alcohol don't mix. Alcohol impairs judgment, balance, and coordination all essential for safe boating.
- 7. Watch the weather. Head back to shore if the skies look threatening. The marine weather channel on your VHF radio can help you keep aware of approaching fronts.
- 8. While water skiing, there's safety in numbers. The driver needs to focus on what's ahead. Make sure there's someone else in the boat to watch you ski.

LORAN-C GENERAL INFORMATION

LORAN-C was originally developed to provide radionavigation service for U.S. coastal waters and was later expanded to include complete coverage of the continental U.S. as well as most of Alaska. Twenty-four U.S. LORAN-C stations work in partnership with Canadian and Russian stations to provide coverage in Canadian waters and in the Bering Sea. LORAN-C provides better than 0.25 nautical mile absolute accuracy for suitably equipped users within the published areas.

Overview: Enhanced Loran is an internationally standardized positioning, navigation, and timing (PNT) service for use by many modes of transport and other applications. It is the latest in the long-standing and proven series of low-frequency, LOng-RAnge Navigation (LORAN) systems and takes full advantage of 21st century technology.

eLORAN meets the accuracy, availability, integrity and continuity performance requirements for aviation non-precision instrument approaches, maritime harbor entrance and approach maneuvers, land-mobile vehicle navigation and location-based services, and is a precise source of time and frequency for applications such as telecommunications.

eLORAN is an independent, dissimilar, complement to Global Navigation Satellite Systems (GNSS). It allows GNSS users to retain the safety, security and economic benefits of GNSS, even when their satellite services are disrupted.

Background: The predecessor of eLORAN, Loran-C, delivered a positioning accuracy of 460m, principally to mariners sailing in coastal and oceanic waters. When the Global Positioning System (GPS) appeared in the 1980s, with its positioning accuracy of tens of meters, many began to regard Loran-C as irrelevant. But others saw it as an essential source of position and time that could still be relied upon if GPS failed.

The US modernization program resulted in this new

version of Loran with significantly improved performance. It has much better accuracy, integrity and continuity while continuing to meet Loran-C's traditional availability requirements. This improvement is realized through the addition of a data channel. This data channel allows eLORAN to meet the very demanding requirements of landing aircraft using so-called non-precision instrument approaches, and bringing ships safely into harbor in low-visibility conditions. eLORAN was also shown to be capable of providing the exceedingly precise time and frequency references needed by the telecommunications systems that carry voice and internet communications.


As eLORAN uses high-powered transmitters and low-frequency signals (not microwatts and microwaves like GNSS), it is very unlikely to be disrupted or jammed by the same causes that would disrupt GNSS signals. This means that small, low-cost, eLORAN receivers, even built into GNSS units, can mitigate the impact of disruptions to GNSS. Moreover, eLORAN can do things GNSS cannot, such as acting as a static compass. At sea, a new concept of navigation – enhanced navigation (e Navigation) – is being developed which requires an exceptionally reliable input of position, navigation and time data. Uniquely, the combination of GNSS and eLORAN has the potential to meet its needs.

While the Administration continues to evaluate the long-term need for continuation of the LORAN-C radionavigation system, the Government will operate the LORAN-C system in the short term. The U.S. Government will give users reasonable notice if it concludes that LORAN-C is not needed or is not cost effective, so that users will have the opportunity to transition to alternative navigation aids. With this continued sustainment of the LORAN-C service, users will be able to realize additional benefits. Improvement of GPS time synchronization of the LORAN-C chains and the use of digital receivers may support improved accuracy and coverage of the service. LORAN-C will continue to provide a supplemental means of navigation. Current LORAN-C receivers do not support nonprecision instrument approach operations.

Unfortunately, there is a move afoot to abandon the LORAN-C system. The deadline for comments to be received was January 8, 2007. While there was not much said locally, there were a great number of comments registered saying primarily that, "relying on ONE electronic navigation system is fraught with inherent danger. Separate, redundant systems are the only practical answer to navigation at night, in fog, inclement weather or any combination thereof."

Let's hope this valuable tool remains in service regardless of the cost.

Via Boat on the Cooper River

The Cooper River Marina is located approximately 2 miles north of the new Cooper River Bridge. When you reach marker # 48, hail the marina on VHF radio, Channel 16.


Via Cosgrove Avenue: Traveling East or West on I-26 (To Charleston or away from Charleston)

Take exit 216, Cosgrove Avenue North. Go to the third stoplight, which will be Spruill Avenue. Take a right onto Spruill and proceed to the third stoplight. Turn left at this light onto Viaduct Road. Proceed over the bridge to the unmanned guard booth and immediately bear right at the sign directing you to Bainbridge Avenue. Take this road to the stop sign where it intersects with Bainbridge. Turn left onto Bainbridge Avenue and continue on until the stop sign. Continue straight through on Bainbridge for approximately 1/ 10 mile. The road will take a small "S" turn to your right and then LEFT. Continue on this road until you reach the stop sign at Juneau Avenue. Turn right onto Juneau and proceed to the end of the road, which ends at the marina parking lot. The marina office is at the end of the pier immediately to your left as you enter the parking lot.

Via Spruill Avenue-West Bound I-26 Only

Take exit 218, Spruill Avenue off of I-26. Proceed to the stop light at Spruill Avenue. Turn left at the stop light and proceed approximately 2 miles to the next stop light. Turn right at the light onto Viaduct Road. Proceed over the bridge to the unmanned guard booth and immediately bear right at the sign directing you to Bainbridge Avenue. Take this road to the stop sign where it intersects with Bainbridge. Turn left onto Bainbridge Avenue and continue on until the stop sign. Continue straight through on Bainbridge for approximately 1/10 mile. The road will take a small "S" turn to your right and then LEFT. 
boats. Lt/C Dick Howells agreed to collect the information after each event and send email to P/Cdr Kromer and Cdr David Walsh.
